Notice regarding Determination of Matters Related to Acquisition of Treasury Shares

(Under the provisions of its Articles of Incorporation pursuant to paragraph 2, Article 165 of the Companies Act)

Nippon Chemical Industrial Co., Ltd., (the Company) announces that matters regarding the acquisition of treasury shares were resolved at the board of directors' meeting held on December 23, 2025, pursuant to the provisions of Article 156 of the Companies Act as applied by replacing certain terms under the provisions of the Article 165, Paragraph 3, of the said Act.

Particulars

1. Reason for acquisition of treasury shares

To increase capital efficiency and enhance shareholder returns.

2. Details of the acquisition

(1) Type of shares to be acquired	Common shares
(2) Total number of shares to be acquired	100,000 shares (maximum) (1.14% of total number of issued shares excluding treasury stock)
(3) Total value of shares to be acquired	260,000,000 yen (maximum)
